<u>Facility Charges</u>	<u>YMCA Member NonProfit Org</u>	<u>NonMember ForProfit Org</u>
1-25 guests	\$100/hr	\$150/hr
26-50	\$125/hr	\$175/hr
51-75	\$150/hr	\$200/hr
76-100	\$175/Hr	\$225/Hr

- All rentals require a **two-hour minimum**.
- Full rental fee must be paid upon reservation of the space.
- Reservation will not be solidified until rental agreement is signed and payment is submitted.
- A two-week time frame is requested prior to rentals to ensure availability and proper communication between YMCA staff.
- A \$20 cleaning fee will be charged to any renter who does not clean up after the duration of their rental
- \*A swim test will be required for all pool party participants conducted by the lifeguard on duty.

### It's An Aquatic Adventure Pool Party!

Have a splashin' good time in the newly updated YMCA pool during your aquatic adventure birthday party! Pool party participants will have one full hour of aquatic fun with access to the YMCA's life jackets and pool toys. A lifeguard will be on duty for safety.

Then, the party continues for the second hour of fun in the meeting room for pizza and cake provided by the YMCA.

- Packages include all set up & take down, pizza, and cake
- Maximum of 20 participants per pool party (or an additional \$10 per child for food and staff costs)
- All participants must complete the facility rental agreement
- The adult responsible for the party must be present throughout the duration of the event
- All parties are customized to the special birthday girl or boy
- Parties cannot exceed 2 hours
- If a party is booked outside of operating hours, additional staff costs will be included (\$10/hour)
